A. IDOT Highway Report – Katie Herdus

Ms. Herdus provided an undate on the

Ms. Herdus provided an update on the McHenry County Management Monitoring Schedule. She noted that the IDOT MPY would be released soon. She also noted that 4 projects were added to the last two lettings and that 2 projects will be on the June letting.

B. Pace Report – Mary Donner

Ms. Donner reported that Pace ridership is down and that the City of Crystal Lake is opposed to any modifications of the Route 550.

C. Metra Update – Rick Mack

Chairman Mack noted that the Cary station is coming along and should be complete by mid-September. Metra is also piloting some additional service during the summer months on weekends.

E. McHenry County Division of Transportation Update – Ben Redding Mr. Redding discussed ongoing work on the Randall Road project and mentioned that the Deerpass Road Bridge would be opening

soon. The County's River/Dowell roundabout project is now complete

- H. CMAP Report Tom Murtha Mr. Murtha provided an update on the CMAQ, STP-L and STP-Shared Fund programs. He also mentioned that the ITEP grant will be available on October 2nd, with Phase I engineering required to be complete before application. HSIP applications are due June 14th and BUILD applications are due July 15th.
- Executive Council of Mayors Committee Report Tom Murtha Mr. Murtha told the Council that the COM Executive Committee sent a letter to the Illinois General Assembly with reforms and a request for additional funding.

- 7. FUNCTIONAL CLASSIFICATION REQUEST- VILLAGE OF BULL VALLEY Ms. Berendt requested reclassification of 5 segments of roadway in the Village of Bull Valley. Valley Hill Road and Cherry Valley Road are proposed to become Minor Collectors due to the fact that these roads are being used by regional traffic as Woodstock and Crystal Lake residents cut through the Village. On a motion by Ms. Smith, seconded by Mr. Nunamaker, the Council unanimously approved the functional reclassification requests.
- 8. REGIONAL STP SHARED FUND- MCCOM BONUS POINT ALLOCATION
 Mr. Summers from the Village of Barrington gave a presentation on their US 14 grade separation project that is requesting bonus points from the McHenry County Council of Mayors. Mr. Hennings from the McHenry County DOT then gave a presentation on the other State and County projects that would be eligible for bonus points. After discussion by the Council, the decision was made to allocate 15 bonus points to the IL 47/IL 176 intersection project and 10 bonus points to the Village of Barrington's project. Mr. Livingston made the motion, seconded by Ms. Berendt. Unanimously approved.
