

<u>Suburban Purchasing Cooperative Awards</u> 2016 Thermoplastic Lane Marking Contract #158 <u>To Superior Road Striping</u>

The Suburban Purchasing Cooperative (SPC), a cooperative of 143 municipalities in the six county area of Northern Illinois, is pleased to announce the award of SPC Contract #158 Thermoplastic Lane Marking to Superior Road Striping of Melrose Park, IL. We are extremely pleased with the results, with pricing 17% lower than last year. Every municipality and government agency in the State of Illinois is authorized to participate in this program.

Three (3) vendors responded to our Request for Proposals (RFP) ranging from a high of \$844,235.22to a low of \$540,366.33, submitted by the winning bidder, Superior Road Striping, with the bid opening attached. The contract is effective for one year, from April 12, 2016 through April 11, 2017 with the SPC reserving the right to extend the contract for up to three (3) possible one-year extensions on a negotiated basis. The RFP was not issued in conjunction with the Illinois Department of Transportation (IDOT), so Motor Fuel Tax (MFT) funds may not be used. However, if you have not already agreed to participate in this year's program, you may still do so. 2016 prices are as follows:
