## Pace Suburban Bus Report McHenry County Council of Mayors 1/13/23

#### **MCRide Extended Hours**

Last year the County Board approved to utilize the one-time Pace 200 thousand dollar grant to extend the hours on the MC Ride Program for the 2023 calendar year. I am proud to report that as of 1/1/2023 the new hours of operation have taken effect. Individuals can now schedule rides from **5am – 11pm** 7 days a week.

To schedule a ride, call the Pace Call Center at 800-451-4599 or 711 for the Illinois Relay Service. Call takers will register you during your first call. Seniors (60+) and individuals with disabilities can schedule a ride up to seven days in advance of their trip. Members of the general public can schedule a ride up to two days in advance of their trip.

#### Pace Suburban Bus College Partnerships

In order to meet the needs of the region, Pace has made recruitment of drivers and mechanics a priority. Last year Pace launched partnerships with local colleges in order to remove financial barriers for the next generation of bus drivers. Through these partnerships, qualified applicants are enrolled in a free 2 week CDL Class "B" commercial drivers license permit class.

#### **Maas Platform Pilot**

As Pace works to leverage technology and innovation to modernize its system and create a better passenger experience, a contract with Quebec, Inc. (Transit) for a two-year MaaS pilot project was approved by the Pace Board. Driving Innovation, Pace's strategic plan, identified the need for Pace to work with a MaaS provider to maximize transit access and ensure equitable regional access and system integration.

As of November 1, 2022, Pace's partnership with the Transit app, which has for years offered trip planning and bus tracking, now offers Pace riders a free Royale subscription in the app. For smartphone users who want to plan trips and track buses in real time via an app, Pace recommends downloading and using the Transit app.

This launch represents Pace's first step towards creating a Mobility as a Service platform that will eventually allow users to see information about all members of Pace's family of service in one easy-to-use place, improving the customer experience.

As soon as you open the Transit app, you'll see nearby bus routes and arrival times. Transit has real-time information for our transit services to help you get around the region. You can also combine bus service with other transportation options in Transit's trip planner.

What features is Pace rolling out later in 2023?

Even more exciting developments in the Pace/Transit partnership are coming later this year including the ability to show Pace On Demand service options in trip planning results.

The *metratracker.com* site, which can be reached directly through that web address or through *metra.com*, features three grey bars on the menu that provide the site's main functions:

- Station Times This option allows customers to check for train departure times from their selected station. When they pick this option, they will be asked to select the line they use and their origination and destination stations. Once they've made their selections and click "Continue," the next page will show all trains scheduled to make that trip in the next two hours, with the train numbers and predicted or scheduled departure times.
- Real-Time Map This interactive map allows customers to see the location of trains along the line or lines that they select, so they can see exactly where their train is and how soon it will reach their station. Customers can click on stations or trains on the map to see real-time information about trains and schedules.
- **Trip Planner** This option allows customers to plan a trip using Metra and other modes of travel between addresses or locations that they select. They can request the "Best Route," "Fewer Transfers," or "Less Walking" and choose "Leave Now" or enter their preferred departure or arrival time.

The new \$26.7 million train tracking system from Clever Devices of Woodbury, N.Y., required the installation of new GPS tracking devices and other network equipment on more than 1,000 railcars and in 238 stations. The new train tracking equipment is currently being installed on Union Pacific, SWS and BNSF trains and tracking on those lines will increase as the rollout is completed this year.

The system has other features that will improve communications. For instance, workers in the Train Reporting and Customer Communications Center (the facility responsible for customer communications) can send texts to trains and platforms that will instantly be turned into audio announcements and displayed on platform signs. On platforms, the system will more accurately announce the arrival of the next train or announce that the next train is running express.

#### Illinois Tollway Update - Winter Information

#### Winter Travel

During changing weather conditions, the Illinois Tollway urges its customers to plan ahead and "Get Winter Ready" during travel preparation. To ensure that all drivers are prepared for winter weather, the Illinois Tollway has provided resources online on best practices for staying safe on the road during hazardous conditions. Travel Information Overview - Illinois Tollway

The Illinois Tollway strives to provide customers safe passage during hazardous weather conditions. Through the Traffic and Incident Management System (TIMS) center, the central operations center for the Tollway, dispatchers have forecasts to plan and prepare for changing conditions, deploy equipment and manage incidents. Utilizing Intelligent Transportation Systems (ITS) deployed throughout the system, the Tollway gathers real-time roadway conditions to properly treat and clear the roads.

#### **Assistance For Drivers**

#### **Move Over Law**

The Illinois Tollway reminds drivers to slow down and move over whenever they approach any vehicle stopped on the roadside that has its hazard lights activated. In 2022 alone, inattentive drivers have struck Tollway vehicles 29 times, a number that is up by more than 30 percent from the previous year. It's a dangerous problem – not just for roadway workers and emergency responders, but for drivers themselves.

The Move Over Law requires drivers to slow down and, if possible, safely change lanes when approaching any vehicle stopped on or along a road with its hazard lights flashing. Drivers who fail to comply with the Move Over Law face serious legal penalties, including fines of up to \$10,000, a two-year suspension of driving privileges and in some cases, a jail sentence. #### **Winter Construction Work Zones**

The Illinois Tollway has moved ongoing construction projects into winter configurations with work scheduled to continue as weather allows. Electronic message signs and construction signage will be put in place in advance to alert drivers to changes in traffic patterns. Work zone speed limits will continue to be in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present. Up-to-date information regarding closures will be available in the Illinois Tollway's <a href="Daily Construction Alert">Daily Construction Alert</a>. All work is weather dependent.

Areas where ongoing winter work zones may impact traffic include:

- The Central Tri-State Tollway (I-294) Project
- The I-290/I-88 Interchange Project at I-294

#### **Commercial Toll Rate Increase**

Toll rate increases are scheduled on January 1 of each year for commercial trucks, buses, recreational vehicles and any vehicles pulling trailers, including in 2023. In 2023, Illinois Tollway commercial toll rates will increase by 3.65 percent in 2023. However, tolls rates at some toll plazas may remain the same because the Tollway rounds rates to the nearest nickel. Tolls rates for trucks and trailers continue to be discounted during overnight hours from 10 p.m. to 6 a.m. at all toll plazas.

#### (If asked)

The Illinois Tollway annual commercial vehicle toll rate increases are linked to the Consumer Price Index (CPU-I). Adopted by the Illinois Tollway's Board of Directors in 2008, annual toll rate increases for trucks and vehicles pulling trailers began January 1, 2015, and were based on percentage change in the CPI-U over a 12-month period. In September 2022, the Tollway Board of Directors approved that future annual commercial toll rate adjustments should be based on the annualized percentage change in the CPI-U over a 36-month period in order to reduce volatility in the annual adjustment from year to year and increase near-term predictability.

#### **CMAP Products and Data**

#### **Greenhouse Gas Emissions Inventory and Local Summaries**

An updated greenhouse gas emissions inventory using 2019 data is now available. This shows that between 2010 and 2019, overall greenhouse gas emissions in northeastern Illinois decreased by 9 percent. While this is progress, the region has a shared goal of reducing emissions by 5 percent annually through 2050, and it fell 36 percent short of the goal.

For the first time, CMAP also produced <u>individualized data summaries</u> by county, community, and Chicago neighborhood that provide a snapshot of emissions from the building, transportation, and waste sectors. Local governments, sustainability committees, and others are encouraged to use this data to develop local climate action plans.

#### Improving Accessibility in the Region

CMAP has launched a program to help communities in northeastern Illinois improve accessibility for their residents and visitors with disabilities. This <u>CMAP webpage</u> provides communities and partners with essential information about improving accessibility and complying with the Americans with Disabilities Act, and advance notice of upcoming CMAP trainings and other information. #### **From Our Partners**

#### Build America, Buy America (BABA) Act

As part of the IIJA, the Build America, Buy America (BABA) Act was expanded beyond what was previously required only for steel/iron products, to now include a list of construction materials also required to be manufactured in the United States. These requirements will commence with the January 20, 2023 letting. To assist in facilitating these new requirements, IDOT has created a "List of Construction Materials Subject to Build America, Buy America (BABA)," which is available on the <a href="IDOT's website">IDOT's website</a>. This list will be updated as more information becomes available from the USDOT/FHWA.

#### **RTA's New Website**

The RTA has launched a <u>new website</u> featuring a refreshed brand representative of a forward-looking vision for the region's transit system. The website was redeveloped to focus on intuitive navigation and to follow Web Content Accessibility Guidelines. The RTA's updated brand brings the agency's external look more in line with its values and vision of accessibility and rider focus.

#### **Municipal Annexation Notification Requirements**

On December 7, 2022 IDOT issued <u>Circular Letter 2022-30</u> providing notice that Public Act 102-969 makes it mandatory to report any annexation, disconnection and annexation, or disconnection to IDOT within 30 days of the action. This information, and the revised boundaries are used for many purposes including, but not limited to, calculation of Motor Fuel Tax distributions, jurisdiction of roads and bridges, and oversize and overweight permits. Public Act 102-969 takes effect on January 1, 2023.

#### **Funding Opportunities**

#### FFY 2024 Highway Safety Program Notice of Funding Opportunities

IDOT's Bureau of Safety Programs and Engineering is seeking grant applications for **six** Highway Safety Programs. These are: the Sustained Traffic Enforcement Program (STEP), Non-Enforcement Program, Pedestrian and Bicycle Program, Racial Profiling Program, Traffic Records Program, and Motocycle Awareness Program. #### FY 2023 Rebuild American Infrastructure with Sustainability and Equity (RAISE) Program

On December 20, 2022 IDOT issued <u>Circular Letter 2022-31</u> announcing that the USDOT is soliciting project applications for the FY 2023 RAISE discretionary grant program. Fiscal Year 2023 RAISE grants are for investments in surface transportation infrastructure projects and will be awarded on a competitive basis to projects that will have a significant local or regional impact and improve: safety, economic strength and global competitiveness, equity, quality of life, mobility and community connectivity, and climate and sustainability. All projects including planning projects have a minimum award of \$5 million for urban projects and \$1 million for rural projects. Grants may not be greater than \$25 million. Applications are due by **February 28, 2023**. Additional information is posted on the USDOT website.

#### Dear Ms. Vega:

The City of McHenry (City) is respectfully requesting an additional \$142,351 in STP funds to cover the increase in cost for Construction and Phase III Engineering. This additional amount will bring the STP total funding to \$1,031,457, which is well below the funding cap of \$1,500,000. The City was awarded STP funds for the subject project on Green Street from Municipal Drive to IL Route 120 during the MCCOM 2020 STP Call for Projects. The estimate of cost for the project was developed in March 2020 at the time of the original application. The project was scheduled for the November 18, 2022 IDOT state letting. The low bidder on the project (Peter Baker & Son Co.) submitted a bid amount of \$1,163,337.14, which was 11.1% higher than the Engineer's Opinion of Probable Cost of \$1,047,238.97. Due to the longer duration between the application for STP funds and the bid opening and the hyperinflation in construction industry, the cost of the project has increased. The City of McHenry is committed to the increase in local share of the cost based on the revised STP amounts. The following tables on the next page summarize the original funding amounts and revised requested amounts for the project:
