#### 2. APPROVAL OF MINUTES - July 21, 2023

Approval of the minutes for the July 21, 2023, McHenry County Council of Mayors meeting. A motion was made by Mr. Lee (Spring Grove) and seconded by Ms. Wilgreen (Crystal Lake) to approve the minutes as presented. The motion carried unanimously.

#### 5. INFORMATION ITEMS

A. Sensible Salting

Scott Kuykendall and Matt Wittim gave a presentation on sensible salting techniques that municipalities could adopt for the upcoming winter.

#### 6. APPROVAL ITEMS

A. STP-L Active Program

Mr. Duffin explained the changes to the STP Program since the July meeting. Ms. Berendt (Bull Valley) made a motion to approve the program, seconded by Mr. Morimoto (Cary). The motion passed unanimously.

B. MCCOM Resolution in support of PART Plan

Chair Mack introduced the item to the Council, explaining the context around the plan and the contents of the resolution. There was some discussion around whether the council needed to submit comments on the plan that day, or if they could have more time to review the plan before commenting. Mr. Kelly (Harvard) made a motion to approve the resolution, seconded by Ms. Betz (Woodstock). The motion passed. The Village of Bull Valley abstained.

C. STP-L 2024-2029 Program Methodology

Mr. Duffin explained the proposed changes to the STP-L scoring methodology. Each change was discussed individually. In situations where there was no clear consensus, a vote was taken to approve or disapprove of the specific change. The following topics were discussed:

Safety – The proposed change, which would combine the Safter Road Index and Crash Reduction Factors to determine a project's score, was approved.

Local Needs – The proposed change was approved by a vote of 8 to 5. Points would be awarded based on the last time that a project sponsor was awarded STP-L funding, regardless of whether they applied for funding in the past.

Complete Streets – The proposed changes were approved. Complete Streets elements would be tiered, and projects would be assigned points based on the number and type of complete streets elements they included. This category was also reweighted to have a maximum of 15 points, rather than 10.

Green Infrastructure – The proposed changes were not approved, and the scoring system used in the previous methodology would remain unchanged. The category was reweighted from 10 points to 5 points.

Maximum Award – The proposed change was not approved. The maximum award would remain the same at \$1,500,000.

Mr. Duffin noted that applications would be accepted between October 16<sup>th</sup> and December 15<sup>th</sup>.

There were no discussion items on the agenda.

#### 8. PLANNING LIAISON REPORT

Mr. Duffin notified the Council of Mayors that CMAP was currently working to develop the FFY 2024 TIP document. He would be contacting municipalities asking for status updates over the next couple of days.

Mr. Duffin also reminded the council that Quarterly Updates for STP-L projects would be due on September 28.

Mr. Duffin notified the council that IDOT had recently announced a Notice of Funding Opportunity for the Illinois Special Bridge Program. Applications for the program would be due on October 31<sup>st</sup>.

#### 9. OTHER BUSINESS/ANNOUNCNEMENTS

There was no other business, and there were no announcements.

#### 2024 regional transit budget advances

The <u>RTA's regional transit budget development</u> cycle continues as the Service Boards have submitted their proposed operating budgets and capital programs to the RTA and will begin holding public hearings throughout the region. The Service Boards will present their adopted budget submissions to the RTA Board at the November 16 meeting, and the RTA will present a proposed regional operating budget, 2-year financial plan, and 5-year capital program at county board meetings throughout the next two months. The final proposed regional budget will be presented for consideration by the RTA Board at their December 14 meeting.

#### RTA developing state legislative agenda

To build support for state legislative action to address the projected fiscal cliff for transit and advance other RTA policy goals outlined in *Transit is the Answer*, RTA Government Affairs staff have developed a <u>state legislative agenda</u> for the agency. This agenda will evolve over time as staff continue to collect feedback and insight from legislators, the RTA board, the <u>*Transit is the Answer* Coalition</u>, and other key stakeholders. The RTA's policy priorities include fully funding the region's transit system; developing a funding structure that is less reliant on rider fares; pursuing reforms and efficiencies that will improve operations; and pursuing reforms to how the state plans, evaluates, and prioritizes transportation projects.

# RTA launches free fare program for survivors of domestic violence

In October, the <u>RTA provided 25,000 transit passes</u> loaded with \$20 each to The Network, an Illinois membership organization advocating to end domestic violence through training, education, and policy advocacy. The Network will distribute the cards to over 50 service providers throughout the RTA region. Survivors who are not currently connected with a service provider are encouraged to call the Illinois Domestic Violence Hotline at 800-799-7233. The initiative is the result of the <u>2023</u> transit omnibus package, which was signed into law in July.

#### Now Open: Access to Transit Program Call for Projects

RTA's <u>Access to Transit Program</u> helps communities improve the infrastructure around their transit stations and stops. Using federal CMAQ and RTA funding, municipalities may apply for small-scale projects, up to \$1 million, that improve access to transit services. The 2023 Call for Projects opened on October 16 and applications are due no later than December 15. More details are available on the <u>RTA website</u>, and a <u>toolkit</u> is available to promote to potential municipal applicants.

All are welcome to join to hear the latest implementation updates and give input on upcoming projects including the 2024 Regional Transit Budget and our 2024 State Legislative Agenda.

#### **Illinois Tollway Update**

#### **I-PASS Assist Program**

More income-eligible drivers are receiving the cost-saving benefits of I-PASS after signing up for I-PASS Assist Accounts that also offer few up-front costs. We've put together a tool kit <u>I-PASS Assist Communications Toolkit - Illinois Tollway</u> if you'd like to promote this program to your residents.

Working through a partnership with the Illinois Department of Revenue and now the Illinois Department of Human services, the Tollway is able to verify the eligibility of households for I-PASS Assist using a secure web form that requires minimal information to determine if household incomes fall below the required threshold, which is based on 250 percent of Federal Poverty Guidelines or if households are currently participating in SNAP or TANF. I-PASS Assist offers eligible drivers all the benefits of I-PASS, including the standard 50 percent discount on tolls, as well as additional benefits, including waiving the transponder deposit fee and allowing drivers to open an account with as little as \$4 in prepaid tolls. In addition, participants may have fees accrued from unpaid tolls dismissed—and avoid future fees for missed tolls. #### The Official Illinois Tollway App

A quick, money-saving way for drivers to pay their tolls and avoid any fees or fines now is as close as their smartphone. It's the <u>Official Illinois Tollway App</u>, which lets drivers use their phones or mobile devices to easily update or manage their I-PASS accounts, including adding or purchasing transponders, adding or changing payment methods and managing rental vehicle or new vehicles. Drivers who don't have I-PASS can use the app to create a Pay By Plate account that automatically pays their tolls. Because safety is priceless, drivers can use the app to call for roadside assistance with the press of a button for help with roadway emergencies so they can safely complete their trips. With the app, paying tolls and saving money is as easy as driving on the Illinois Tollway.

#### Notice of Violation for Unpaid Tolls

Starting in April, customers who have received multiple invoices and reminders for the same unpaid tolls will receive a notice of violation that, if ignored, will result in a \$20 fine assessed on each unpaid toll. These fines will be in addition to any previously assessed invoice fees.

Customers can go to <u>https://www.illinoistollway.com/ves</u> and search by license plate or invoice to identify unpaid tolls.

As the Tollway begins reinstating violation notices, customers with outstanding initial toll invoices issued between June 1, 2020, and September 30, 2022, will have a six-month hold placed on notices and will be eligible for a discount of up to 50 percent off fees on paid

invoices. In addition, income-eligible customers who qualify for I-PASS Assist and also establish an I-PASS account may have their fees dismissed.

Customers with outstanding initial toll invoices issued on or after October 1, 2022, will be issued a Notice of Violation, which may result in an additional \$20 fine per toll. However, customers will have an opportunity to dispute violations including via a hearing.

Since unpaid toll invoicing began in 2020 along with the agency's transition to cashless tolling, the Illinois Tollway estimates that more than 6 million invoices have gone unpaid, with a troubling trend of repeat non-compliance in a growing number of customers. This includes more than \$110 million in unpaid tolls over the past three years.

Dear Members of the McHenry Council of Mayors,

The City of Harvard is writing to formally request additional funding for the Diggins Street Resurfacing Project, which was initially granted funding by MCCOM. We are facing unforeseen cost escalations that necessitate adjustments to the overall cost of the project.

The Diggins Street Resurfacing Project is a critical endeavor for our community, aimed at enhancing safety and infrastructure along truck route in Harvard. It is located near our growing industrial zone and is a main thoroughfare for truck traffic as well as serving as western access to our historic downtown. Initial estimates for construction and construction engineering totaled \$531,216, with MCCOM committing \$471,240.

Unforeseen factors, including escalating unit pricing within the construction industry and the discovery of special waste during the project, have led to a significant increase in project costs. The City has already forgone drainage improvements initially detailed due to cost increases. This additional cost has placed a substantial financial burden on our small, low-median-income community.

MCCOM's bylaws typically authorize cost increases of up to 10% of the initial funding allocation, equivalent to \$47,124. However, due to the magnitude of unforeseen expenses and their impact on our community, we wanted to ask if it would be possible to receive \$81,200 total in additional consideration, to cover these costs. Covering the total amount would allow the City of Harvard to focus on other areas in need with many large projects coming up for a community of our size. Currently we are pursuing Marengo Road and Bridge Improvements, sidewalks along 173 to our downtown area, and sidewalks along Route 14 to make our retail area more accessible to foot traffic from all reaches of the City. All of these projects will take a toll on our limited resources.

Any supplementary funding is critical to ensure the successful completion of the Diggins Street Resurfacing Project, maintaining the safety and well-being of our residents. We understand the need for thorough evaluation and pledge to use every allocated dollar judiciously for the project's benefit.

Your understanding of our circumstances and commitment to improving McHenry County's infrastructure are greatly appreciated.

The Village of Prairie Grove was awarded STP-Local funds on November 7, 2022, for the Barreville Road from Ames Road the Village limits, TIP ID 11-22-0036. At the same time, the City of McHenry was awarded STP-Local funds for Barreville Road from City limits to Bull Valley Road, TIP ID 11-22-0030. The projects abutted and were subsequently combined into one project, from Ames Road to Bull Valley Road, with the Village of Prairie Grove leading the project under the TIP ID 11-22-0036. As such, the funding for both projects were combined and allocated for Phase I in FFY 2025, Phase II in FFY 2026, and Construction and Construction Engineering in FFY 2027.

It is understood that the Construction and Construction Engineering funding is to currently remain in FFY 2027 due to funding constraints in FFY 2025 and FFY 2026. That said, we request that the funding for Phase I and Phase II be allocated in FFY 2025. This schedule change allows for Phase I and Phase II engineering to be completed under one contract and provides the opportunity to begin construction earlier should funding become available.

Please find enclosed a Functional Classification Revision Application for your review and Council approval for the referenced roadway location. Also included are Regional and Local Location Maps.

Broadway Street is an east-west roadway directly connecting downtown Richmond, residential neighborhoods, schools, and churches to adjacent IDOT arterial roadways leading to other destinations in central and north McHenry County and beyond. Broadway Street is a focal point and important collector route within our community. This FAU route revision will upgrade Broadway Street to a FAU minor collector designation from Kenosha Street (IL Route 173/FAP 303) to the west and North Main Street (US Route 12 / FAP 334) to the east (0.86 miles). Broadway Street meets the FHWA definition of a minor collector route as it links locally important traffic generators with adjacent major routes, it serves both land access and traffic circulation in lower density residential and commercial areas, and it distributes vehicle trips between local routes and arterials.

Also note the western 0.35 miles of this segment is under the jurisdiction of Richmond Township. A letter of support from Richmond Township is attached.

Please review this request and if this information is acceptable, please prepare a resolution supporting the functional classification for action at the next council meeting.

Currently there are 15 private driveways and 10 commercial driveways.

Broadway Street is a two (2) lane roadway with a combination of angled and parallel parking on both sides between West Street and N Main Street. The travel lanes are separated by double yellow pavement markings from IL Route 173 to West Street. From West Street to N Main Street, there are no pavement makings separating lanes. Broadway Street consists of an urban cross section to the east of West Street and a rural cross section to the west of West Street.





